

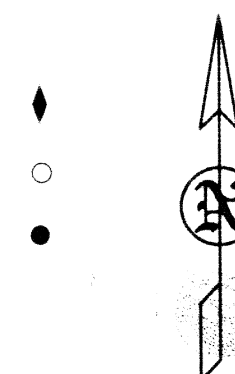

NARRATIVE

The purpose of this plat is to partition Parcel 1 of Partition No. 1995-005 in the W1/2NW1/4 of Section 4, T10S, R37E, WM into three parcels at the request of Richard Haynes of Dick Haynes Trading LLC.

The exterior of the land to be partitioned by this plat is Parcel 1 of Partition No. 1995-005 as adjusted in June, 2000, and recorded as Baker County Survey No. 10-37-126. All the survey information found on the said partition plat is applicable to this survey. All the exterior monuments were set by the previous surveys and only one monument was needed to make the new parcels.

The access road is reserved as a private easement for utilities and the exclusive use of the owners and their guests of this partition and Parcel 2 of Partition No. 1995-005. The road easement is 60 feet wide, 30 feet on each side of the described centerline.

There are no water rights of record.

CERTIFICATION

I, Leland Lee Myers, a Professional Land Surveyor registered in the State of Oregon, 587 E. Auburn Street, PO Box 99, Sumpter, Oregon 97877, completed the survey of this partition on May 16, 2001, by setting proper monuments and do hereby certify that the information shown on this plat is correct to the best of my knowledge, and in accordance with ORS Chapter 92.

The Initial Point for this partition is the N 1/16th corner on the line between Sections 4 & 5, T10S, R37E, WM, which is a 2" galvanized pipe with a 2 1/2" aluminum cap set by PLS 848 in 1983.

Thence, following a portion of the northeasterly boundary of Three Bar Ranch Lands through the SW1/4NW1/4 of Section 4, all points being No. 5 rebar, S86°19'31"E, 45.80' feet;

Thence, N89°48'48"E, 186.05' feet to the True Point of Beginning;

Thence, S60°56'23"E, 140.79' feet;

Thence, S36°57'56"E, 207.60' feet;

Thence, S36°44'46"E, 239.54' feet;

Thence, S16°19'23"E, 101.58' feet;

Thence, S15°16'06"E, 145.82' feet;

Thence, S65°45'24"E, 248.23' feet;

Thence, S65°42'32"E, 499.80' feet to a point on the west one-sixteenth line, which point is N3°14'35"W, 349.09' feet of the center-west 1/16th corner;

Thence, along the sixteen line and departing from Three Bar Ranch Lands boundary, N3°47'46"W, 983.44' feet to the NW 1/16th corner;

Thence, along the north 1/16th line and the boundary of the City of Sumpter Sewer Lagoon property, S89°41'26"W, 330.00' feet to a 1994 PLS 699 No. 5 rebar;

Thence, along the sewer lagoon to another PLS 699 No. 5 rebar, N52°30'00"W, 428.00' feet;

Thence, along the line between Parcels 1 and 2, Partition No. 1995-005 as adjusted in Property Line Adjustment dated June, 2000, S51°31'00"W, 486.06' feet to the True Point of Beginning, a parcel of containing 16.92 acres of land.
