A pine, 18 ins. diam., bears S.17°E., 47 lks. dist., mkd. T10S R 37E S17 BT. A pine, 14 ins. diam., bears S.20°W., 84 lks. dist., mkd. T10S R 37E S18 BT. A pine, 16 ins. diam., bears N.68°W., 50 lks. dist., mkd. T10S R 37E S7 BT.

The cor. of secs. 7,8,17, and 18, determined at record bearing and distance from the remains of the original bearing trees:

A pine, 36 ins. diam., bears N.75°E., 40 lks. dist., with scribe marks T10S R 37E S8 BT visible on open blaze.

## At the corner point

Set an iron post, 28 ins. long, 2½ ins. diam., 24 ins. in the ground, with brass cap, from which new bearing trees:

A ponderosa pine, 12 ins. diam., bears N.21°E., 39½ lks. dist., mkd. T10S R 37E S8 BT. A ponderosa pine, 15 ins. diam., bears S.21°W., 217 lks. dist., mkd. T10S R 37E S18 BT.

A ponderosa pine, 11 ins. diam., bears N.10°W., 115 lks. dist., mkd. T10S R 37E S7 BT.

No other trees available within limits.

Bury a basalt stone,  $10 \times 7 \times 4$  ins., with an X chiseled on W. face, alongside iron post, and raise a mound of stone, 2 ft. base,  $1\frac{1}{2}$  ft. high, W. of the corner.

The corner is located 54 lks. south of a fence, extending N.45°W. and S.45°E.

## Description of corner evidence found:

Found a 2½" BLM brass cap, 4" out of the ground, in a mound of stone, from which:

A pine, 17" diam., bears N.12°43'W., 75.6', scribed "T10SR37ES8BT". A pine snag, 25" diam., bears N.70°10'W., 33.1', scribed "T10SR37ES7BT". A pine, 36" diam., bears N.75°28'E., 26.4', scribed "T10SR37ES7BT". A pine, 21" diam., bears S.13°35'E., 31.4', scribed "T10SR37ES17BT".
