A pine, 18 ins. diam., bears S.25°E., 8 lks. dist., mkd. T10S R37E S26 BT. A fir, 18 ins. diam., bears S.40°W., 58 lks. dist., mkd. T10S R37E S27 BT.

A tamarack, 14 ins. diam., bears N.40°W., 52 lks. dist., mkd. T108 R37E 827 BT.

Owen C. Chatters, II and Lester E., Fisher, Cadastral Surveyors July 26, 1974

The cor. of secs. 22, 23, 26, and 27 perpetuated by person(s) unknown, monumented with an iron pipe, 2½ ins. diam., projecting 8 ins. above the ground, from which the remains of the original bearing trees:

A pine stump, 18 ins. diam., bears N.44°E., 36 lks. dist., with scribe marks BT visible on open blaze. (record N.40°E)

A pine stump, 20 ins. diam., bears \$.25°E., 8 lks. dist., with scribe marks BT visible on open blaze.

A root hole, bears \$.40°W., 58 lks. dist., with a down fir alongside, size indeterminate, no marks visible.

A western larch snag, 16 ins. diam., bears N.40°W., lks. dist., mkd. T10S R37E S22 BT visible on open blaze.

At the corner point

Set an iron post, 28 ins. long, 2½ ins. diam., 24 ins. in the ground, with brass cap, from which new bearing trees:

A ponderosa pine, 11 ins. diam., bears N.7°E., 73½ lks. dist., mkd. T10S R37E S23 BT. A western larch, 12 ins. diam., bears S.68°E., 115 lks. dist., mkd. T10S R37E S26 BT. A western larch, 11 ins. diam., bears S.14°W., 33 lks. dist., mkd. T10S R37E S27 BT. A ponderosa pine, 7 ins. diam., bears N.38°W., 46 lks. dist., mkd. T10S R37E S22 BT. Bury a basalt stone, $4 \times 4 \times 3$ ins., with an X chiseled on W. face and reset the iron pipe alongside iron post.

Found 1971 BLM brass cap in good condition, stamped as shown in diagram, with steel post set 4 ft. NE, from which:

A 14" western larch bears S68°E, 115 lks., with blaze healed over.

A 13" western larch bears S14°W, 33 lks., with blaze healed over.

Maintained corner by attaching "Land Surveying Monument" sign to steel post and bearing trees as needed, painted 6" wide red bands around bearing trees, and making new accessories:

A 14" western larch, bears N61°30'W, 25.19 ft., scribed T10SR37ES22BT. A 9" western larch, bears N7°10'E, 37.76 ft., scribed T10SR37ES23BT.

A tamarack, 15" diam., bears S.9°55'W., 21.7', with healed blaze.

A tamarack,, 8" diam., bears N.6°11'E., 37.8', scribed "T10SR37ES23BT", with nail and washer " PLS 699".

A tamarack, 16" diam., bears S.71°30'E., 75.3', with healed blaze, and a nail on side.
