At the corner I found no evidence of the original corner post. I found the NW BT to be 24" stump marked BT bearing N41°W 64.7 ft. The SW BT is a 30" stump marked BT bears S70°W 36.3 ft. There are rotted remains of the two remaining BTs at proper bearing and distances.

At the intersect of the distances of the two BTs I set a 21/2" x 32" aluminum capped pipe 26" in the ground from which:
