

## NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF RUSSELL AND KARREN HANSON ON BEHALF OF FRANCIS PASCOE—TULLIS REUNION, INC. AND ANGELO AND VICKI TURRA. THE PURPOSE OF THIS SURVEY WAS TO MONUMENT A PROPOSED PROPERTY LINE ADJUSTMENT APPROVED BY THE BAKER COUNTY PLANNING DEPARTMENT AS PLA—17—012. THE INTENT IS FOR MR. AND MRS. TURRA TO CONVEY THE EAST 10 ACRES OF W1/2NE1/4SE1/4 SECTION 8 TO FRANCIS PASCOE—TULLIS REUNION, INC.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. THE EAST QUARTER CORNER OF SECTION 8 WAS REMONUMENTED BY THE B.L.M. FROM ORIGINAL EVIDENCE IN 1971. SECTION 8 WAS SUBDIVIDED BY JAMES HANLEY, PLS, IN 1994 DURING THE COURSE OF SURVEY NO. 10—37—37. ALSO IN 1994, LELAND MYERS, PLS, MONUMENTED THE N1/16 CORNER AS PART OF SURVEY NO. 10—37—76. IN 1995, DAVID SCHURIAN, PLS, PERFORMED A CADASTRAL SURVEY FOR THE U.S. FOREST SERVICE RECORDED AS SURVEY NO. 10—37—80. DURING SAID SURVEY, HANLEY'S PINS FROM SURVEY 10—37—37 MARKING THE NE1/16 AND CE1/16 CORNERS WERE FOUND AND REMONUMENTED WITH FOREST SERVICE MONUMENTS.

I ACCEPT ALL THE FOUND CONTROLLING MONUMENTS SHOWN HEREON. NEW MONUMENTS WERE SET AT POSITIONS ACCORDING TO THE EVIDENCE FOUND, AND AS APPROVED BY BOTH LANDOWNERS. I ALSO POSTED THE ADJUSTED LINE WITH STEEL U POSTS AND FLAGGING.


