SURVEYOR'S CERTIFICATE

I, James D. Hanley, certify that I have correctly surveyed Parcel No. 1 and platted Parcels No. 1 and 2 of this minor partition in accordance with O.R.S. Chapter 92. The parcel boundary is described as follows:

Beginning at a point which bears N89°57'55"E. 420 feet from the Southeast corner of the SW1/4SW1/4 (Lot 4) Section 7, Township 10 South, Range 38 East, Willamette Meridian, said point being on the South line SW1/4 Section 7 and on the Easterly side of a rail fence; thence N.01°21'25"W. along the said Easterly side of a rail fence 209.05 feet; thence S.89°57'55"W. 495.12 feet; thence N.00°15'32"W. 750.00 feet; thence N.89°57'55"E. 466.27 feet; thence N.00°17'13"E. 182.74 feet; thence N.89°57'55"E. 560.69 feet to the West side of USFS Road 5-93; thence following said road the following courses: S.12°04'13"E. 384.14 feet, along a 738.20 foot radius curve left (the long chord of which bears S.22°13'41"E. 260.33 feet) 261.77 feet, S. 32° 23' 10" E., 621.44 feet to the South line said SW1/4 Section 7; thence S.89°57'55"W. 1036.07 feet to the Point of Beginning.

New monumentation was established at the Northwest and Southwest corners of Parcel No. 1. Parcel No. 2 was not surveyed for the purposes of this plat.

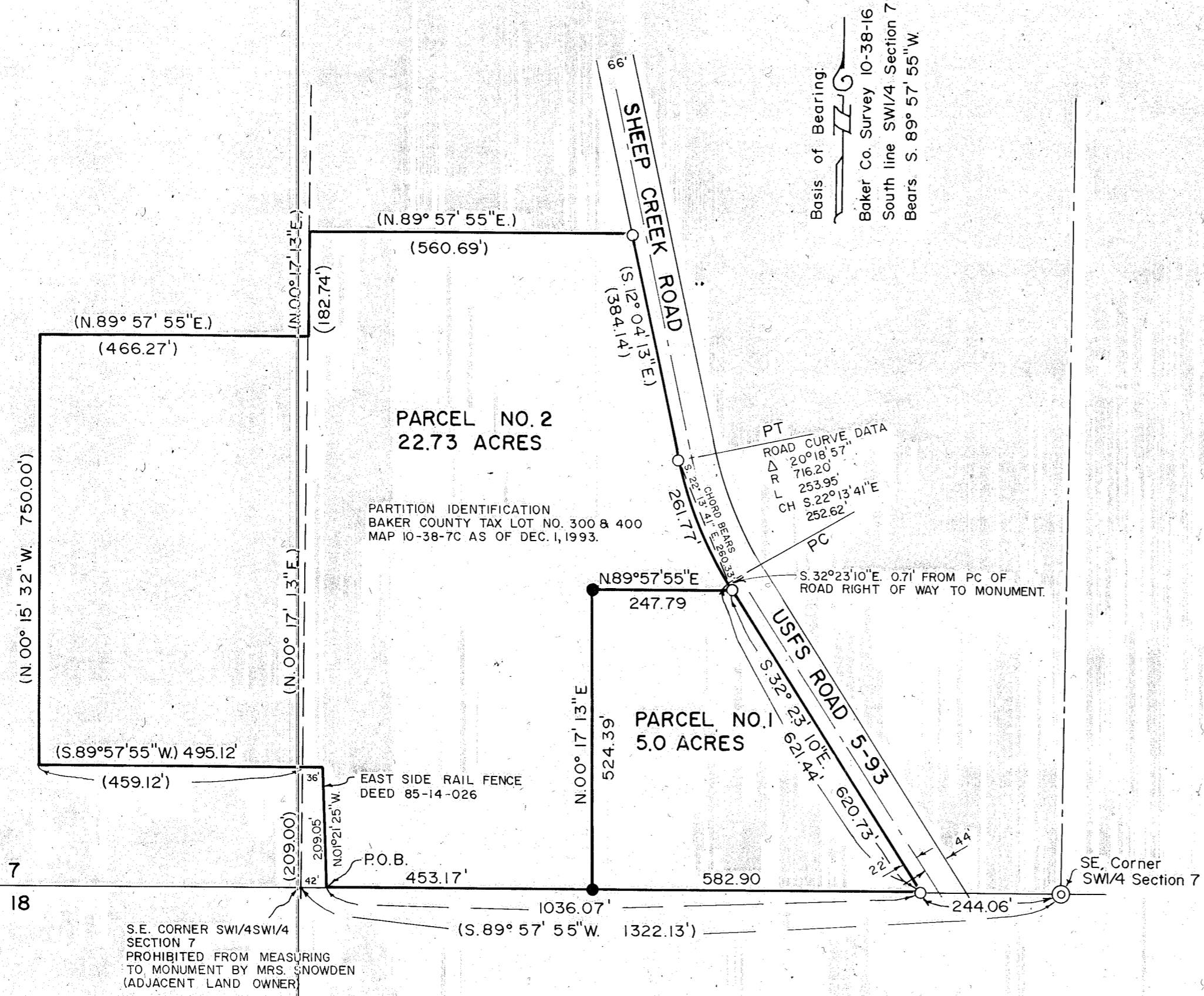
