

ORIGINAL G.L.O. DESCRIPTION: Set a post 3 ft. long 3 ins. square 12 ins. in ground for ¼ sec. cor. marked ¼ S. on N. face. From which a pine 24 ins. dia. bears S10°W., 20 lks. dist. marked ¼ S BT. A pine 24 ins. dia. bears N68°W., 31 lks dist. marked ¼ S BT.

EVIDENCE FOUND: After a thorough search, I was unable to find any evidence of original GLO corner or accessories. I therefore determine this corner to be lost.

DESCRIPTION OF MONUMENT AND ACCESSORIES SET:

At a position determined by proportionate measure between the NE and NW corners of section 30, set 5/8" x 30" iron pin 28" in the ground, with $2\frac{1}{2}$ " aluminum cap marked as shown below. Built a 2 ft. mound of stone around the corner.

FROM WHICH, I set the following reference points:

A $5/8" \times 30"$ iron pin, bears N.47°20'E., 67.65 ft., with attached yellow plastic cap mkd. BENCHMARK SURVEYING.

A 5/8" x 30" iron pin, bears S.14*56'E., 37.23 ft., with attached yellow plastic cap mkd. BENCHMARK SURVEYING.

A 5/8" x 30" iron pin, bears N.46*53'W., 13.61 ft., with attached yellow plastic cap mkd. BENCHMARK SURVEYING.

ALSO FROM WHICH, I scribed the following bearing tree:

A Ponderosa Pine, 9" diam., bears S.78°30'W., 30.95 ft. dist. mkd. ¼S30 BT. Attached yellow BT tag.
