

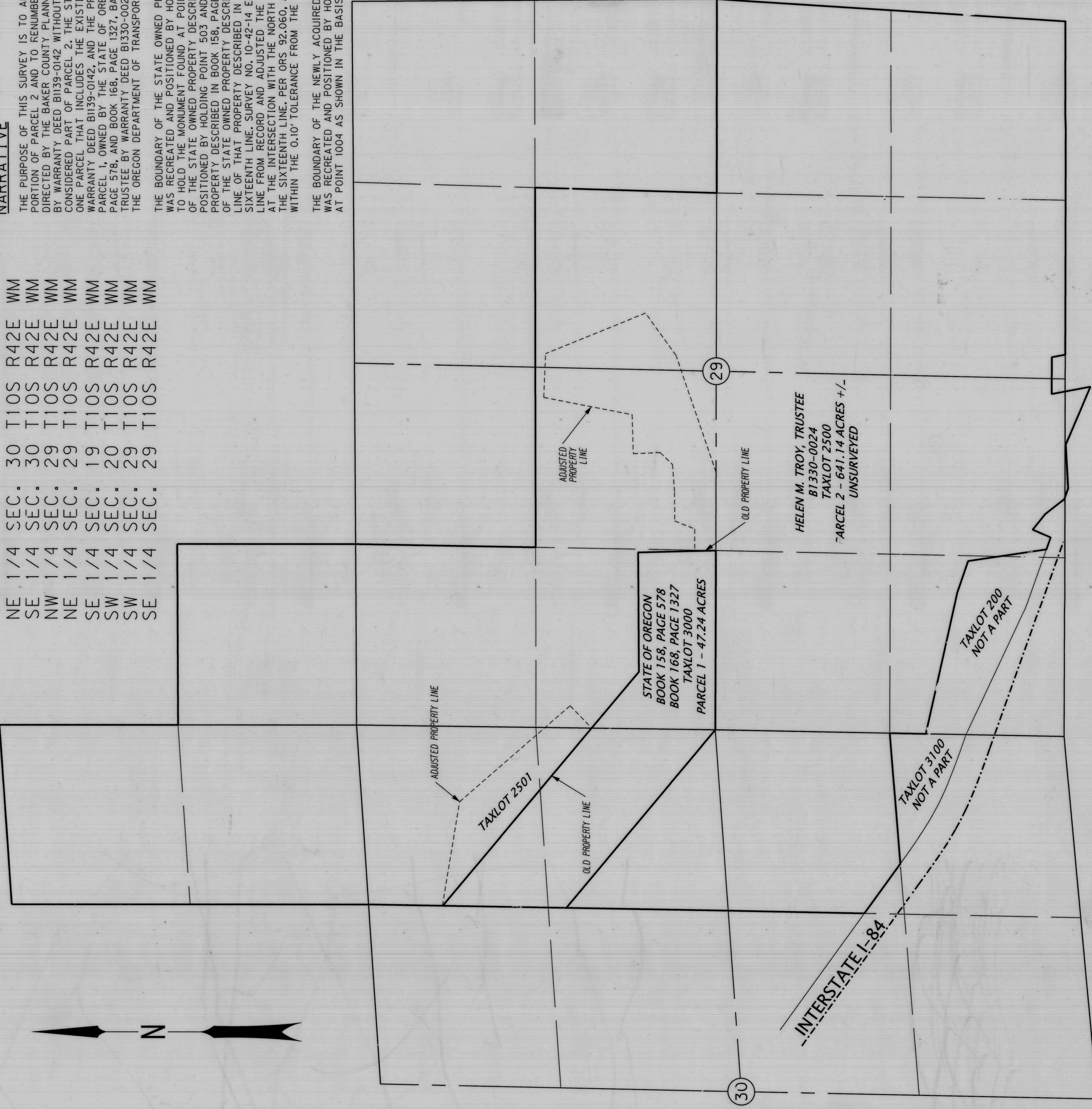
NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO AMEND SURVEY NUMBER 42-10-0019 TO SHOW ALL OF THE UNSURVEYED PORTION OF PARCEL 2 AND TO RENUMBER THE PARCELS INVOLVED IN THE PROPERTY LINE ADJUSTMENT AS DIRECTED BY THE BAKER COUNTY PLANNING DEPARTMENT. TAX LOT 2501 WAS EXCEPTED FROM TAX LOT 2500 BY WARRANTY DEED B1139-0142 WITHOUT GOING THROUGH THE LAND USE PROCESS AND IS THEREFORE STILL CONSIDERED PART OF PARCEL 2. THE STATE OF OREGON DEPARTMENT OF TRANSPORTATION WISHES TO CREATE ONE PARCEL THAT INCLUDES THE EXISTING STATE OWNED QUARRY PROPERTY, THE PARCEL OBTAINED BY WARRANTY DEED B1139-0142, AND THE PROPERTY OBTAINED BY STIPULATED GENERAL JUDGMENT B1817-0093. PARCEL 1, OWNED BY THE STATE OF OREGON, WAS ACQUIRED BY WARRANTY DEEDS RECORDED IN BOOK 158, PAGE 578, AND BOOK 168, PAGE 1327, BAKER COUNTY DEED RECORDS. PARCEL 2 IS OWNED BY HELEN M. TROY, TRUSTEE BY WARRANTY DEED B1330-0024. THIS PROPERTY LINE ADJUSTMENT SURVEY IS BEING REQUESTED BY THE OREGON DEPARTMENT OF TRANSPORTATION (ODOT) REGION 5 GEOLOGY SECTION.

THE BOUNDARY OF THE STATE OWNED PROPERTY DESCRIBED IN BOOK 158, PAGE 578 & BOOK 168, PAGE 1327 WAS RECREATED AND POSITIONED BY HOLDING THE WEST QUARTER CORNER OF SECTION 29, AND ROTATED TO HOLD THE MONUMENT FOUND AT POINT 502 AS SHOWN ON SURVEY NO. 10-42-14. THE BOUNDARY OF THE STATE OWNED PROPERTY DESCRIBED IN WARRANTY DEED B11-39-0142 WAS RECREATED AND POSITIONED BY HOLDING POINT 503 AND ROTATED TO ALIGN WITH THE NORTH LINE OF THE STATE OWNED PROPERTY DESCRIBED IN BOOK 158, PAGE 578. THERE IS AN ENCROACHMENT AT THE WESTERLY LINE OF THE STATE OWNED PROPERTY DESCRIBED IN BOOK 158, PAGE 578, THEREFORE THE NORTHWESTERLY LINE OF THAT PROPERTY DESCRIBED IN DOCUMENT B11-39-0142 WAS SHORTENED TO TERMINATE AT THE SIXTEENTH LINE. SURVEY NO. 10-42-14 ERRONEOUSLY CHANGED THE BEARING OF SAID NORTHWESTERLY LINE FROM RECORD AND ADJUSTED THE BEARING SO THAT SAID NORTHWESTERLY LINE WOULD TERMINATE AT THE INTERSECTION WITH THE NORTH LINE OF THE PROPERTY DESCRIBED IN BOOK 158, PAGE 578 WITHIN THE 0.10' TOLERANCE FROM THE CALCULATED CORNER POSITIONS FROM RECORD DIMENSIONS.

THE BOUNDARY OF THE NEWLY ACQUIRED TRACT DESCRIBED IN STIPULATED GENERAL JUDGMENT 18CV01150 WAS RECREATED AND POSITIONED BY HOLDING THE MONUMENT FOUND AT POINT 1000 AND THE MONUMENT AT POINT 1004 AS SHOWN IN THE BASIS OF BEARINGS INSERT ON ODOT DRAWING IR-03-1811.

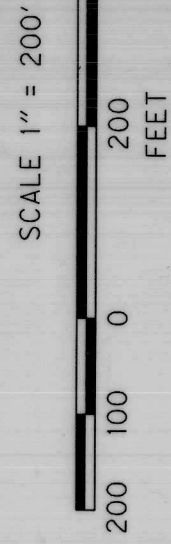
