**Description:** The cor. of secs. 20, 21, 28 and 29, monumented with a limestone, 15x10x6 ins. (**Record:** 16x10x8 ins.), lying loose in the center of an embedded mound of stone, 6x3 ft. in size, mkd. with 4 notches on an edge and 2 notches on an edge 90° to the 4-notch edge.

At the corner point

Set an aluminum post, 30 ins. long, 2 1/2 ins. diam., 26 ins. in the ground, over a plastic-encased magnet, and in a collar of stone, 1 1/2 ft. diam., to the top of an aluminum cap marked as shown on this corner record.

Buried the original limestone alongside the aluminum post. Added a witness mound of stone on E. edge of the collar of stone surrounding the aluminum post, 3 ft. base, 1 ft. high.

Set a carsonite post N. of the aluminum post, approximately 3 ft. dist.


