

EVIDENCE FOUND: After searching the area, I found no evidence of the original corner. I established its position at single proportionate measure between the found monuments at the southwest and southeast corners of Section 35, T.10S., R.39E. However, during the monumentation process, as we were building a mound of stone around the pipe, we found a 29"x14"x7" basalt stone with 5 notches on one edge that had been moved into the mound. We were unable to determine the original position of this marked stone, but we know that the stones used in the mound were collected from within arm's reach of the proportionate position. After examination of the soil line on the marked stone, it was clear that this stone was not set in the ground as described in the G.L.O. field notes, but had been lying loose on the ground. As I still had no acceptable evidence as to the original position of this stone, I declare this corner lost, and established its position at proportionate measure, as stated above. ## DESCRIPTION OF MONUMENTS AND ACCESSORIES SET AND METHODS USED:

Show how trees are scribed and basis of bearings including compass var. At the corner point: I set a 12"x30" galv. iron pipe, 12" in the ground, with attached Bagett, Griffith and Blackman brass cap marked as shown.
