## **NARRATIVE**

This survey was done at the request of Steve McClelland, on behalf of Hancock Forest Management, land manager for the land within. Mr. McClelland wanted the corners monumented as shown hereon in preparation to a timber sale. Many of the corners of Section 16 were brought to county standard by the BLM in 1970 and the section was subsequently subdivided by Doug Ferguson in Survey Number 11—39—72. I recover the monuments as shown hereon. I find the interior aliquot corners set by Ferguson to be in good condition and relatively harmonious with his survey, with the exception of the Center—North 1/16th corner. Aside from this corner, I accept the position of the monuments as found on the ground. I use the mathematical position at the Center—North 1/16th for further subdivision of the section. I place the corners as per BLM Manual of Instructions 2009. The legal description created in conjunction with the partition indicates the Parcel 7 to be the East 1400.00 feet of the portion of the SE quarter lying NE of the centerline of Denny Creek Road and the East 1400.00 feet of the South half of the Northeast quarter. I establish this by perpendicular offset from the East line of the section. This places a 0.53 foot jog at the North line of the Southeast quarter. Due to the size of the property, I only monument the Westernmost pin. Along Denny Creek road, I set the pin 30 feet offset from the constructed centerline of the road. I find no other unusual conditions with this survey.
