Corner originally established under GLO contract number 418, executed by Henry W. Cooke, dated August 30th 1881. Surveyor General field notes


Set post 3ft long, 3 in. square, with marked stone 12 ins deep for 1/4 sec cor. marked 1/4 S on West side from which:

Corner remonumented by Peter A. Peterson, Albert J. Garrison, and Owen C. Chatters, under special instruction group number 350, dated May 3rd 1957. BLM survey record states:

Set an iron post, 28 ins. long, 2 1/2 ins. diam., 20 ins. in the ground, in a mound of stone, 2 ft. base to top, with brass cap mkd. from which: A ponderosa pine, 12 ins. diam., bears North 41° East, 73 lks. dist., mkd.

1/4 S22 BT.

A fir, 12 ins. diam., bears South 25° West., 104 lks. dist., mkd. 1/4 S21 BT.

DESCRIPTION OF CORNER EVIDENCE FOUND:

Found a 2 1/2" iron pipe with a 3" "US Dept. of Interior Bureau of Land

Management" brass cap, 6" above ground , from which:
A 17" diam. Douglas Fir bears South 25° West, a distance of 68.64 ft., alive and vigorous with healed blaze.

A 12" diam. stump bears North 41° East, a distance of 48 feet, with "T" scribe visible on badly deteriorated remains.

Steel fence post falls approx. 3 ft. South



A 9" diam. Ponderosa Pine bear South 48° East, a distance of 30.75 feet, marked 1/4 S22 BT. A 6" diam. Ponderosa Pine bears North 51° West, a distance of 28.70 feet, marked 1/4 S21 BT.

Falls on East aspect approx. 40 ft above N/S road.
