Office remonumented this corner during a Dependent Resurvey under special instructions dated January 26, 1938 and letter dated September 15, 1938 for the surveys included under Group No. 219

ORIGINAL DESCRIPTION: Set a basalt stone 16x7x6 ins. for 1/4 Sec Cor. marked 1/4S on W. side, and raised mound of stone, around stone.

1938 DESCRIPTION: The 1/4 sec. cor., which is a basalt stone, 18x8x6 ins., firmly set in a mound of stone, marked 1/4 on W. face.

At point for cor. Set an iron post, 3 ft. long, 1 in. diam., 6 ins. in the ground to bedrock, with the original stone deposited at the base, and in a mound of stone to top, for 1/4 sec. cor., with brass cap marked

EVIDENCE FOUND: I found a 1" iron pipe with attached $2\frac{1}{2}$ " diameter brass cap leaning and loosley projecting from a very large mound of stone. I also recovered the original marked stone west and alongside at the base of the pipe, per Gould's notes. The stone measured 18"x8"x6" and was marked 1/4S on one face. I accept the position of the base of the Gould's pipe as the 1/4 corner.

DESCRIPTION OF MONUMENTS AND ACCESSORIES SET AND METHODS USED:

I stood the pipe up veritcally and rebuilt the mound around the pipe to the top of the cap. The brass cap is marked as shown below.

From which, I SET THE FOLLOWING REFERENCE POINTS:

- ► A 5/8"x30" iron pin bears N.34°55'E., 49.06 ft. with attached yellow plastic cap marked BENCHMARK SURVEYING.
- ► A 5/8"x30" iron pin bears S.36°15'E., 31.67 ft. with attached yellow plastic cap marked BENCHMARK SURVEYING.
