
CERTIFIED RECORD OF LAND CORNER MONUMENTATION



SET 1-1/2" ALUMINUM CAP ON A 5/8" X 30" IRON ROD, UP 1" ABOVE THE GROUND, WITH A POST WITH PADDLE PLACED ALONGSIDE. THE CAP IS MARKED AS SHOWN BELOW.

THE REFERENCES SET FOR SAID CORNER ARE AS FOLLOWS:

1) A 5/8" X 30" IRON ROD WITH A 1-1/2" ALUMINUM CAP, UP 1", STAMPED "ODOT"
