NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF LEA GREENWOOD, ACTING IN BEHALF OF THE UNITY COMMUNITY RECREATION DISTRICT.

THE PURPOSE OF THIS SURVEY WAS TO LOCATE THE CORNERS OF THE COMMUNITY HALL TRACT AS SHOWN HEREON.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. FIELD MEASUREMENTS WERE MADE TO LOCATE THE APPURTENANT MONUMENTS OF RECORD SURVEY NO. 13-37-18, SET IN NOV. 1994 BY JAMES HANLEY, PLS 1206. WE FOUND FOUR OF THE CONTROLLING MONUMENTS AS SHOWN HEREON. THE SW MONUMENT OF THIS TRACT WAS MISSING.

I HELD THE RECORD BEARING AND DISTANCE FROM THE FOUND MONUMENTS AT THE SE AND NW CORNERS OF THIS TRACT AND RESET THE SW CORNER AT ITS RECORD POSITION.
