I, Thomas J. Hanley, certify that I have correctly surveyed, monumented and platted three parcels of land on the annexed partition map in accordance with O.R.S. Chapter 92. The boundary of the partition is as follows; Land located in the West half of the Southwest quarter of the Southeast quarter of Section 16, Township 13 South, Range 37 East, Willamette Meridian, Baker County, Oregon, more particularly described as follows:

Beginning on the Easterly right of way line of Job Creek Road (Baker Co. Rd.
