

ORIGINAL G.L.O. DESCRIPTION: Drove cottonwood post 3 ft long and 3½ ins Square for cor. to Sec 19, 20, 29 and 30 marked T13S S19 on NW, S20 on NE, S30 R37E on SW, S. 32 on SE faces. dug pits 20x12x10 ins. in each Sec. 5½ ft. dist and raised a mound of earth 2½ ft. high 3 ft diam. at base around post.

**EVIDENCE FOUND:** In the vicinity of the search area for this corner, we found deteriorated remains of a fence running north and south. Henderson's notes state, "descend" immediately after he returned to said corner. We found no evidence of the post or pits and mounds, but i did accept a location at which the terrain descended along the old fencing material for the corner position.

DESCRIPTION OF MONUMENT AND ACCESSORIES SET:

At the corner point I set a 5/8"X30" iron pin with attached 2½" aluminum cap, 27 inches the ground. Built a 2 ft. mound of stone around iron pin. Cap is marked as shown below.

A 5/8"X30" iron pin bears S.42\*41'E., 29.54 ft., with attached yellow plastic cap marked BENCHMARK SURVEYING

A 5/8"X30" iron pin bears S.37°00'W., 38.23 ft., with attached yellow plastic cap marked BENCHMARK SURVEYING

A 5/8"X30" iron pin bears N.52°35'W., 36.28 ft., with attached yellow plastic cap marked BENCHMARK SURVEYING
