## RECORD OF LAND CORNER MONUMENTATION



ORIGINAL G.L.O. DESCRIPTION: Drove cottonwood post 3 ft long and 3 ins Square for cor. to Sec 29, 30, 31 and 32 marked T13S S30 on NW, S29 on NE, R37E S31 on SW, S. 32 on SE. dug pits 20x12x10 ins. in each Sec. 5½ ft. dist and raised a mound of earth 2½ ft. high 3 ft diam. at base around post.

EVIDENCE FOUND: At the vicinity of the search area for this corner, we found the remains of scattered deteriorated fencing running north, south and west. The old fencing remains run sporadically for over 2½ miles generally in a straight line along the east lines of sections 19, 30 and 31. I determined the position of the northeast corner of said section 31 at the intersection of the old fences running North, South and West.

DESCRIPTION OF MONUMENT AND ACCESSORIES SET:

At the corner point I set a 5/8"X30" iron pin with attached 2½" aluminum cap, 30 inches the ground. Built a 2 ft. mound of stone around iron pin which falls on the east side of a road running North—South. Cap is marked as shown below.


FROM WHICH, I SET THE FOLLOWING REFERENCE POINTS:

A 5/8"X30" iron pin bears N.33\*22'E., 44.14 ft., with attached yellow plastic cap marked BENCHMARK SURVEYING

A 5/8"X30" iron pin bears S.44°37'E., 28.80 ft., with attached yellow plastic cap marked BENCHMARK SURVEYING

A 5/8"X30" iron pin bears S.26°23'W., 30.83 ft., with attached yellow plastic cap marked BENCHMARK SURVEYING

A 5/8"X30" iron pin bears N.17°13'W., 51.14 ft., with attached yellow plastic cap marked BENCHMARK SURVEYING
