Surveyor General records state:

Set basalt stone 16 x 12 x 7 ins, 11 ins in the ground for cor to secs 1, 6, 7 & 12 marked with 1 notch on N and 5 notches on S edges and raised a mound of stone alongside. This corner is on steep and rocky N hillside. Pits impractical.

Description of corner evidence found:

A balalt stone 16 x 12 x 7 with fragmentary chislework in a mound of stone... JRM location tags and attention signs on two trees nearby.

None established during original survey.

Description of monument and accessories I established to perpetuate the original location of this corner:

At position of found stone... Set a $2\frac{1}{2}$ " aluminum cap on 2" aluminum pipe 30" long, 12" in the ground to refusal with 18" projecting out of the ground and a surrounding rock mound with a 6' steel fence post alongside with a sign 54-9 attached. Cap marked as shown. Buried marked stone alongside.

New bearing trees established: A mahogany 6 ins dia bears $S85^{\circ}W$, 38.0 ft dist marked T14SR36ES12 BT. A fir 7 ins dia bears N46 $^{\circ}W$, 35.9 ft dist marked T14SR36ES1 BT.

Each new bearing tree has a brass washer marked PLS 1639 nailed flush with BT blaze and has signs 54-3 and 54-9 attached below a surrounding band of red paint.
