ORIGINAL DESCRIPTION: Set an iron post, 3 ft. long, 1 in. dia., 27 ins. in the ground, for 1/4 sec. cor. of sec. 33 only, with brass cap marked (diagram shown) from which

A white fir, 30 ins dia., bears N. 45° W., 407 lks. dist., marked 1/4 S33 BT.

A black pine, 8 ins dia., bears N. 12 3/4 ° W., 278 lks. dist., marked 1/4 S33 BT.

HANLEY'S DESCRIPTION: Original iron corner monument not found and presumed destroyed by logging activity. A fir 38 ins diam with healed blaze and a pine 20 ins diam with healed blaze for original accessories.

At position established from original accessory evidence set a aluminum cap on an aluminum pipe 30 inches long with 26 inches buried in the ground and 4 inches projecting out of the ground with a surrounding rock mound and a 6 foot steel fence post alongside with a sign 54-9 attached.

Aluminum cap marked thus: (diagram shown)

Each original bearing tree has a sign 54-3 attached above the BT blaze and has a sign 54-9 attached on the opposite side of the tree and has a 6 inch band of red paint around.

EVIDENCE FOUND: Found 2 ½" aluminum pipe with 2 ½" aluminum cap, marked as shown below, projecting 8" above ground, in a 2 ft. diameter mound of stone, with a steel fence post with attached USFS 54-9 sign set West, 4 ft. from monument.

From which,

- ► A lodgepole pine, 24" dbh, bears N.12 ¼°W., 183.48 ft., in good condition with a healed blaze (GLO BT).
- A white fir snag, 32" dbh, bears N.45°W., 268.62 ft. (GLO BT).

DESCRIPTION OF MONUMENTS AND ACCESSORIES SET AND METHODS USED:

From which, I SCRIBE NEW BEARING TREES:

- ► A western juniper, 8" dbh, bears N.51°E., 53.65 ft. marked *T8SR37E1/4S33BT* in single blaze.
- ▶ A western juniper, 12" dbh, bears S.68°E., 21.08 ft. marked X in upper blaze and BT in lower blaze.
- ▶ A western juniper, 19" dbh, bears S.55°W., 71.80 ft. marked X in upper blaze and BT in lower blaze.

Painted a 6 inch red band around each bearing tree, painted the blazes red, and attached USFS 54-3 and 54-9 signs. Used a magnetic compass with 14° East declination to measure bearings to BT's. Used an EDM device to measure distances to new bearing trees, measuring to a 60d nail driven in the side-center-right at the root crown of the tree, with an attached $1\frac{1}{2}$ " aluminum washer stamped PLS 69454.
